You may have noticed the 'For Sale or Lease' banner recently posted on the Masonic Center building. **The trustees are exploring all options** since the United Way board has decided to not renew their lease for the office space they currently occupy as of September 30, 2013. This space comprises approximately 60% of the total lease space in the building. With the extremely tight and competitive commercial real estate market in the Wausau area, it is necessary the Trustees of the Association explore all possibilities which might include the sale of the facility and/or lease of the space. **NOTHING HAS BEEN DECIDED AT THIS POINT!**

If the best option for the future would be the sale of the existing facility, all proceeds would be used to establish a new Masonic facility in Wausau to provide a home for all Masonic bodies well into the future and create an endowed operating fund. Please be assured that the Trustees take their fiduciary responsibilities extremely seriously and will always act in the best interests of the local Masonic bodies.
